- The North Penn School District Board of School Directors invites bidders to submit sealed bids for the furnishing and delivery of NPHS Crawford Stadium SMPTE Fiber Project.
- Bids will be accepted until 12:30 PM on Tuesday, June 8, 2021. The bids will be opened at 1:00 PM on June 8, 2021 via Zoom. Please see NPSD website, www.npenn.org/bidspec, for Zoom meeting details one hour prior to the bid opening.
- 3. The bid must be submitted in a sealed envelope and clearly marked on the outside, "NPHS Crawford Stadium SMPTE Fiber Project".
- 4. Bids shall be submitted <u>on the enclosed Bid Proposal Form</u>. Bids must be typewritten or written with ink and signed by the individual, partners, or corporate officer.
- 5. The successful bidder shall bid in strict accordance with the specifications as set forth. **No substitutions or alternates** are permitted.
- 6. A BID BOND OR CERTIFIED CHECK IN FAVOR OF THE NORTH PENN SCHOOL DISTRICT IN THE AMOUNT OF 10% OF THE TOTAL BID IS REQUIRED FROM EACH BIDDER AND MUST BE ENCLOSED WITH THE BID. THE BOND MUST BE ISSUED BY AN INSURANCE COMPANY.

- 9. Bidder shall insert the price per stated unit and the total cost extension against each item in the schedule hereto annexed, which the bidder has proposed to furnish and deliver. The unit price inserted must be net and must include all delivery charges No Exceptions. In the event of a discrepancy between the unit prices and the total cost extension, the unit price will govern. The total bid is to be the sum of the quantity times the unit price for each item.
- 10. A purchase order issued by the School District covering any or all items included in this bid shall constitute a contract binding upon the bidder and the School District.
- 11. No charge will be allowed for federal, state, or municipal sales or excise taxes, for which the school district is exempt by law. The bid price shall be net and shall not include the amount of any such tax. Exemption certificates, if required, will be furnished on forms provided by the bidder.
- 12. The bidder agrees, if awarded an order, to furnish and deliver the said articles at such time, to such place, and in such quantities as specified, and that all of the articles shall be subject to the inspection and approval of the School District. Acceptance of delivery of materials or equipment to the site shall not constitute final acceptance by the School District. In the event that any articles are rejected as damaged, or not in conformance with these specifications, such articles shall be removed immediately and other articles of proper quality as set forth in these specifications shall be furnished in place thereof, all at the expense of the successful bidder.
- 13. In the event that the successful bidder should neglect or refuse to furnish or deliver any articles or any part thereof, or to replace any articles which are rejected as stated in the preceding paragraph, then the School District is authorized and empowered to purchase articles in conformity with this order from such party or parties, and in such manner as it shall select, at the expense of the successful bidder, or to cancel the contract reserving to itself, nevertheless, all rights for damages which may be incurred by the School District.
- 14. Invoicing: Invoices must be submitted for each individual school, completely itemized, and covering each shipment. They should show North Penn School District item numbers, the same as packing slips. No photocopy of a Bid or Purchase Order will be accepted in lieu of an itemized invoice.

SMPTE Connections will be utilized with Hitachi Z-HD5000 Camera and Hitachi CU-HD500. The vendor will provide all parts as specified and terminate fiber and copper connections per manufacturer's specifications.

Vendors will pull all cable, terminate, install panels, boxes as specified. All fiber connections will be terminated with an ST connector. SMPTE copper connections will be provided by the vendor and terminated with the appropriate body pins and sockets. Each ST and Copper connection will be tested to ensure termination meets manufacturers specifications. 2" inch conduit is provided to each location.
