



# North Penn School District Property Tax & Rent Rebate Program

## SCHOOL TAX REBATE PROGRAM USING YOUR PA-1000 REBATE APPLICATION

If eligible for the Pennsylvania Property Tax and Rent Rebate Program (Form PA-1000 for 2022), the School District rebate will again be available to eligible homeowners, renters, hybrid owners, and supplemental payments in a rebate amount of up to 90% of the rebate received through the Pennsylvania program. The maximum North Penn rebate per household for 2023-24 is \$877.50.

Even if you were not eligible in prior years, you may be eligible this year. Please obtain and complete a District Rebate Application form for the 2023-24 school tax year and submit it with the two required documents to see if you qualify. ### **Expansion to Property Tax/Rent Rebate Program – Changes Coming in 2024**

Under the expansion first proposed by the Governor, nearly 175,000 more Pennsylvanians will qualify for a property tax or rent rebate. At the same time, many of the 430,000 claimants who previously qualified under the program’s prior guidelines will see their rebates increase.
